Terms of Reference: To advise the Board to create International Tourism Circuit, to develop a Cultural, Archaeological and devine tourism corridor along the bank of Sarasvati River in the State.

The Committee shall advise/suggest the Board to built partnership with Institutions, Organizations working in and outside the State at International level which may assist in under CSR/PPP model or any other deemed fit to achieve the Board's Aims and Objectives.

Nature of Scope: To develop Tourism and a Cultural corridor along the course of Sarasvati Heritage Area palaeo-channels.

To revitalize sacred areas and take up façade improvement of surrounding areas for safety/stability/conservation in the Sarasvati Heritage Area.

To create effective linkages between tourism and cultural facilities by developing Tourism Circuits and conservation of natural resources in the Sarasvati Heritage Area.

Development of amusement places, parks, car parking, coffee shops, restaurants, handicrafts centres and other tourism based infrastructure for tourist attraction in Sarasvati Heritage Area.

Developing a land use perspective plan of the Sarasvati Heritage Area.

Tenure: Creating cultural awareness among the local residents.
The tenure of the Committee will be of two years from the date of its notification.
It shall meet every three months or any time as Chairman decides.

Expenses: The expenses on travelling and local hospitality in respect of Non-Official Members will be borne by the Haryana Sarasvati Heritage Development Board. The status of the members shall be Grade-I for TA purpose.
